

# ISRC & Registration

IFPI worldwide is the International Agency appointed by ISO (International Organization for Standardization) to administer the International Standard Recording Code – ISRC for purpose of music recording title identification includes by electronic means. IFPI (Hong Kong Group) Limited is the official agent appointed by IFPI as Local ISRC Agency in Hong Kong to administer the assignment of the ISRC Registrant Codes to qualified applicants in Hong Kong. The applicant upon proof of identity supported by a valid Hong Kong Business Registration Certificate (BR) with sufficient proof that it is predominantly a Hong Kong music company, and warrant to abide by the rules under the ISRC Handbook and Official Bulletins published and revised from time to time, would be recorded as a Registrant and assigned the exclusive use of a unique range of ISRCs for their assignment to their own music recordings. The Applicant shall be a music recording business duly registered and having its Principal Place of Business in Hong Kong. A proof of address is required by 2 independent papers. Due to the emerging trend for independent artistes to produce their own music recording as copyright owner including as self-release artiste, we office to cover them for ISRC Application. The application requirement is slightly different but reflected under the Application Form. However, the Artiste Without a Label (AWAL) must be a Hong Kong ID Card holder with the same level in proof of address.

To address the increasing number of applicants in recent years that may soon deplete available Registrant Codes, IFPI (Hong Kong Group) Limited has stopped assigning Registrant Codes but in turn assign a range of codes to each new applicant ("Limited Code Registrant"). As a result, currently the agency assigns two sets of ISRC Blocks per successful Registrant, one set for sound recordings and the other set for audio-visual recordings (such as music videos).

It is the duty of ISRC Registrant to keep proper record and make available to ISRC Agency under official request such record of assignment promptly. This is essential in particular under renewal of application for additional blocks of codes for suitability of extension. The format is according to your undertaking under your signed application.

In principle, the value of the First Copyright Owner to assign a unique ISRC to each of its recordings for publication is still highly regarded as a way to maintain a single ISRC as unique identifier to each recording. When such recording copyright is licensed/transferred to a third party, the First Copyright Owner must inform the licensee/next owner of the ISRC so assigned.

A mere licensee of recordings should therefore ask the original copyright owner for the original assigned ISRCs for any use. Assigning an ISRC by a licensee must be conducted under consent by the original owner and with a clear understanding that there was no ISRC assigned to the recording before.

The Registrants are responsible to keep full record of all codes they have assigned, and submit to IFPI (HKG) Limited the metadata when demanded or under an annually report. This is essential for proper management by the agency. The list of

metadata required under the Registrant Report is listed under the Application Form. It may be revised from time to time for future assignments. The up-to-date metadata file format can be requested from [isrc@ifpihk.org](mailto:isrc@ifpihk.org).

Due to the design of ISRC system, the Hong Kong ISRC agency does not entertain application from entities coming from different copyright jurisdictions including which effectively is an overseas entity.

The ISRC assignment is open to non-members and it is still free of charge up to now.

In applying for ISRC Registrant, the applicant should download a copy of the Application Form available from [www.ifpihk.org](http://www.ifpihk.org). The applicant should complete, sign and submit the Application Form to us at [isrc@ifpihk.org](mailto:isrc@ifpihk.org) with all supporting documents for smooth processing.

Obtaining ISRC blocks from IFPI (Hong Kong Group) Limited does not make it a member of the group. Membership application is entirely a separate process.
